At the annual general meeting of unitholders of HK Electric Investments (the “Trust”) and shareholders of HK Electric Investments Limited (the “Company”), as convened by HK Electric Investments Manager Limited (the “Trustee-Manager”, in its capacity as the trustee-manager of the Trust) and the Company, held on a combined basis as a single meeting characterised as the annual general meeting of holders of share stapled units (the “Share Stapled Units”) on 10 May 2017 (the “AGM”), all the proposed resolutions as set out in the notice of AGM dated 31 March 2017 were voted on by poll.
