At the annual general meeting of unitholders of HK Electric Investments (the “**Trust**”) and shareholders of HK Electric Investments Limited (the “**Company**”), as convened by HK Electric Investments Manager Limited (the “**Trustee-Manager**”, in its capacity as the trustee-manager of the Trust) and the Company, held on a combined basis as a single meeting characterised as the annual general meeting of holders of share stapled units (the “**Share Stapled Units**”) on 12 May 2021 (the “**AGM**”), all the proposed resolutions as set out in the notice of AGM dated 7 April 2021 were voted on by poll.
