Each of the Ordinary Shares and the Preference Shares which forms a component of a Share Stapled Unit is fully paid up.*

The Share Stapled Units, and individually the Units, the Ordinary Shares and the Preference Shares are all listed on the Main Board of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”). However, for so long as the Share Stapled Units are listed on the Stock Exchange, trading on the Stock Exchange will only take place in the form of Share Stapled Units.
